- 1. Since more number of candidates are being called for the counseling, this call does not confer any admission into the course for those who have called for the counseling.
- 2. Candidates should report at the Counseling centre one hour before the scheduled time with **all original certificates** as listed under information brochure along with prescribed fees. Fee shall be paid on the spot during counseling on allotment of seat.
- 3. Candidates, who got admission earlier into B.Sc. (Hons.) Horticulture course in Dr.YSRHU are eligible for sliding through 2nd counseling and they have to submit the following documents during the sliding.
 - a. Allotment Letter
 - b. Fee paid receipts.
- 4. Category wise seats vacancy position and fee particulars are available in the University website: http://drysrhu.ap.gov.in. All the candidates are requested to go through the guidelines available in the University website before appearing for counseling.

NOTE:-

Open Completion (OC) means all eligible candidates belonging to Non-Farmer, Farmer irrespective of category & special categories as per the state ranks indicated in the table and not on category basis (by merit only). Those candidates under reserved categories, who do not secure seat under OC will have to attend counselling again on respective scheduled date.

- 1. For Un-Reserved quota, any candidate from AU, SVU, OU region with **A.P. EAPCET 2022 Rank** can compete on merit.
- 2. The seats under B.Sc. (Hons) Horticulture course shall be filled through A.P. EAMCET 2022 Ranks duly following existing reservation rules.

- 3. The candidates are required to produce all the relevant original certificates at the time of counseling for verification. The candidates who got admission shall pay the prescribed fee immediately after allotment of seats to the concerned college counter ie., Rs.46,418/- for general seat, Rs.1,25,878/- for payment seat and Rs. 54,802/- for private college seat.
- 4. Selection of candidates under S.C., S.T. and B.C. quota is subject to certification by the respective social status Directorates of Government of Andhra Pradesh.
- 5. This notification shall be treated as individual intimation and no separate intimation will be sent.
- 6. The seats falling vacant due to non-joining /cancellation subsequently shall be filled up on the next counseling only.
- 7. Physical presence of student is compulsory and only one parent / guardian per student will be allowed at the counseling centre.
- 8. It is presumed that counseling process may be extended to late in the evening. Hence, the candidates, parents & guardians are requested come prepared for the counseling.
- 9. Counseling for admission into B.Sc. (Hons.) Horticulture under CAP (Defence) and P.H. quota will be conducted on the same day i.e., on 30-12-2022.
- 10. Counseling for admission into B.Sc. (Hons.) Horticulture under NCC and Sports quota will be conducted separately and the schedule will be announced later.
- 11. If the admitted candidate cancels his / her seat before the closure of admissions for the academic year 2022-23, an amount of Rs.3,550/- shall be collected towards seat cancellation fee for General candidates and for SC/ST/PH candidates Rs.1,775/-. The remaining fees already paid during admission shall be refunded.
- 12. If the admitted candidate cancels his / her seat after closure of admission process for the academic year 2022-23, the candidate forfeits the fees already paid and in addition, he /she has to pay an amount of Rs.3,550/- towards seat cancellation fee for General candidates and for SC/ST/PH candidates Rs.1,775/-.
