In comply of the directions issued by the Hon'ble High Court of Andhra Pradesh on W.P.No.3861/2015 vide reference (2) cited and in accordance with the orders in the reference (4) cited, the following candidate, who has selected to the post of **Assistant Professor** cadre under Backlog (SC/ST) direct recruitment in the discipline of **Genetics & Plant Breeding** in the Faculty of Horticulture is hereby appointed to Assistant Professor cadre post with effect from the date of his joining in the post.

1. Mr. Srinivasa Rao, M. - SC

He shall be governed by such conditions of service in regard to leave, retirement as provided in the Statutes and Regulations of the University including the following. The above appointee is eligible for new Contributory Pension Scheme.

- I. **Scale of Pay and Allowances:** The appointment is made in the scale of pay of Rs. 57,700 - 1,82,400 (Revised UGC Scale of Pay, 2016), which is equivalent Scale to Rs. 15,600 - 39,100 + 6000 AGP (Revised UGC Scale of Pay, 2006) plus usual allowances.
- II. **Probation:** The appointee shall be on probation for a period of two years on duty within a continuous period of three years from the date of joining. Provided that the passing of Department Test will be a mandatory and probations, shall be declared only after passing of Departmental Test, if not already passed, and that all the new recruitees shall pass Account Tests for Subordinate Officers Part-I within a period of five years from the date of joining. In the event of any teachers failing to pass the Account Test Part-I within the stipulated period of 5 years, the increments shall be stopped. Declaration of their probations will be subject to their satisfactory performance during the period of probation and probation is liable to be terminated at any time before declaration of probation after giving one month's notice or paying one month's pay in lieu of such notice.
- III. **Bond :** He shall execute a bond (Proforma enclosed) on Non-Judicial stamp paper worth of Rs. 100/- to serve the University for a minimum period of two years as per university in Regulations, and further to the effect that. They will not proceed for further studies or apply for accept another position outside the University within two years from the date of joining University service except by resigning the post in the University after paying six months salary or salary for the period for which she has still to serve the University, whichever is less, subject to a minimum of one month's salary. He will be admitted to duty only after executing the bond.
- IV. **Medical Fitness:** He shall produce a Medical Certificate of health obtained from a Gazetted Medical Officer or a Registered Medical Practitioner in the prescribed form (copy enclosed)
- V. **Transfer :** He shall be liable to be transferred to any equivalent post in teaching, research and extension wings of the University.

VI. Dr.YSRHU Conditions of Service of Teachers and other Employees Regulations:

He should serve for at least six years in remote and difficult areas i.e. B & C category centres of which three years shall be in remote areas ('C' class centre) and three years in backward area ('B' class centers) during the entire period of service, except in case of highly specialized disciplines for which equivalent posts are not available in such areas. Failure to comply with the above rule attracts disciplinary action and disqualification for promotions, etc.

VII. Others Terms and Conditions:

- a. He should give an undertaking to the effect that he/she will serve in the place of posting at least three years.
- b. He will be true and faithful and shall at all times, when required, render a true and just account thereof to the University or to such persons as shall be authorized to receive the same.
- c. He will not, during the continuance of their employment without the consent in writing to the University be employed for interested directly or indirectly in any other trade or business, employment or occupation whatsoever, but will devote the whole of his time and attention to the duties in the University.
- d. Termination of Service or Resignation :

A permanent officer shall be required to give three months notice in case he desires to be relieved or he shall pay to the University three months salary in lieu of such notice, unless otherwise directed by the Board of Management.

VIII. Time allowed to join duty: If he accept the terms of his appointments, he should join duty on or before **27.09.2021** failing which the appointment will be cancelled without any further notice.

On appointment the following postings are ordered.

- (1) Mr. Srinivasa Rao, M is posted as Assistant Professor (Genetics & Plant Breeding) at College of Horticulture, Parvathipuram in the existing vacancy.

The candidate is requested to furnish all the original certificates to the Head of Office for verification.

The Head of Office is requested to admit the newly recruited Assistant Professor after submission of bond and physical fitness certificate only. Also requested to verify the correctness of the bond to include six months gross salary and two sureties should be employees of the University not below the rank of Assistant Professor with five years of regular service. They are further requested to intimate the date of joining of the above individual to the University along with original bond for record.
