HOSTEL RULES AND REGULATIONS - 2019

(To maintain harmony and peace in the hostels)

- 1.** The Associate Deans, Principals shall make frequent visits to the hostels especially during nights.
- 2.** No unauthorized person should be allowed to stay in the Hostels.
- 3.** A Committee of teachers may be constituted to interact with the students to find out their grievances and also to make visits to hostels to assist the College administration in maintaining Harmony and Peace among the students.
- 4.** The Advisory system should be strengthened and regular meetings between the students and advisors shall be arranged.
- 5.** Mess Timings shall be followed strictly. The mess timings and menu shall be displayed at the dining hall as well as in the Notice Board of hostel and the timings shall be strictly followed. All the Mess bills shall be accounted for properly.
- 6.** The Matter relating to peace and Harmony in the Hostels shall be reviewed by the Associate Deans/ Principals/Head of Department, Wardens, In-charge student activities, and Academic- in charges at regular intervals.
- 7.** The Associate Dean/Principal and Hostel Warden may call for a meeting of boarders once in a month.

- 8.** The Parents may be informed whenever the students are involved in any act of indiscipline in Hostels.
- 9.** The Associate Deans and Principals shall exercise their powers first and the matter may be referred to the University only when it is beyond the powers of the Head of Institution.
- 10.** The Heads of Institutions shall encourage participation of students in Sports, Games, Cultural and Literary activities so that their attention may be deviated from the act of indiscipline.
- 11.** Visitors Hours shall be strictly implemented in Hostels especially in all the Girls Hostels. Visiting hours should be displayed
- 12.** The Wardens shall instruct the Hostel Workers to behave properly with the boarders and the boarders also shall deal with the Hostel Workers decently without entering into any arguments.
- 13.** The Wardens and Caretakers shall ensure quality of food in the Hostels.
- 14.** Prior permission shall be taken by the boarders from Associate Dean, Wardens and Advisor by submitting a letter if the boarder is leaving the Hostel for more than one week.
- 15.** The rooms in hostels shall be allocated to boarders as per the alphabetical orders of their names in respect of boarders admitted in the hostels.

- 16.** Each block of the hostel shall be demarcated for the boarders on the basis of year of study.
- 17.** All the boarders in the hostels shall vacate their rooms during RHWE Programme and during the summer break.
- 18.** The rooms shall be reallocated afresh to the boarders at the beginning of every academic year on the basis of year of study.
- 19.** 'A complaint box' shall be fixed at a prominent place in each of the hostels and signed complaints with full name and address shall only be attended.
- 20.** The boarders of hostels shall not conduct any meetings in the hostel either in the rooms or outside on their own. The meetings with the boarders shall be convened by Hostel Wardens/Chief Wardens only whenever required.
- 21.** The chief Warden and Warden shall identify the 'Best Hosteler' and 'Best Hostel Room' in every hostel at the end of every year after observing for a period of one year. Such students shall be awarded with prizes and certificates at the 'College Day/Hostel day' Celebrations.
- 22.** The boarders of the hostel shall not leave the hostel after 5.30 PM for girls and 7.00 PM for boys for any purpose without the prior written permission of Hostel Warden.
- 23.** The boarders shall carry their identity cards, whenever they go outside the hostel and produce the same to

the security / Inspecting team / Warden/Chief Warden or any authorised person on demand.

- 24.** A 'Movement Register shall be maintained at the entrance /exit of the hostel and the boarders shall make an entry in the register whenever they go out of the hostel and come back.
- 25.** Any boarders of the hostel, who entertains an un authorized person in his/her room or in the hostel, shall be liable for suspension from the hostel.
- 26.** The boarders shall not use electrical appliances such as immersion coils, heaters, stoves etc., in the rooms or anywhere in the hostels. Action shall be initiated against the boarders using electrical appliances.
- 27.** The expenditure towards the replacement of electrical bulbs / tubes in the room shall be borne by the boarders themselves. However the expenditure towards replacement of electrical bulbs /tubes in common areas, such as bathrooms, toilets, corridors etc., shall be met from the hostel contingencies.
- 28.** The boarders shall not indulge in cooking food in the rooms, including preparation of tea/coffee or boiling milk etc. Any boarder indulging in cooking inside the room or anywhere in the hostel shall be liable for action.
- 29.** The food shall be served only in the mess and no food item shall be taken to the rooms or outside the dining hall. In the case of patients , as per the advice of the

Medical Officer, the food may be served in the room by one of the hostel workers with the permission of hostel warden.

30. Mess bills shall be displayed every month on 10th in the notice boards of hostels. Bills shall be cleared every month by 15th. After 15th Rs.10/- shall be charged (fine) per day up to the month end. Afterwards with the written permission from chief warden one may be permitted to pay the fine up to one more month. Afterwards one will not be allowed to dine in the mess.
31. All the items required for the mess in the hostel such as provisions, vegetables, fruits, eggs, meat etc., shall be purchased by the purchasing committee and not by an individual member of the committee, accompanied by caretaker.
32. The news papers / magazines /Journals purchased for the hostel shall be made available in the 'Common room' only. One of the boarders of the hostel shall be made responsible for the making availability of reading material in the hostel. The boarders are not permitted to take News papers/ Magazines / Journals to their rooms or to any other premises from the common room.
33. No posters or banners of any kind shall be displayed in the hostel premises by the boarders. They shall not indulge in writing on the walls or doors anywhere in the hostel. Action shall be taken against such boarders, who indulge in display of poster, banners and writings on the walls.

34. An undertaking to the effect that student shall abide by hostel rules and regulations and that, action shall be taken as per the rules and regulations of Dr.YSRHU against the boarders if he/she indulges in any act of indiscipline in the hostel, including ragging, shall be obtained by the boarders as well as the parents of the boarders at the time of admission.
35. The furniture and the electrical fittings, available in the rooms of the hostel shall be recorded in a register and the acknowledgment of boarder(s) be obtained, whenever the rooms are allotted to boarders and these items are also verified at the time of vacating the room by the boarders.
36. The boarders shall not consume liquor or any other intoxicants in the rooms or anywhere in the hostel. The boarders if found intoxicated shall be expelled from the hostel.
37. Maintenance of recreation facilities like T.V Room, GYM room and Reading room timely by attending to repairs if any to the equipment.
38. TV room shall be closed by 10.00 PM and opened at morning 6.00AM
39. All vehicles (2 wheelers and cycles) of the boarders shall be parked outside the hostel in cycle stand and they shall be properly locked.
40. GYM room shall be kept open from 6.00 AM to 8.00 AM and in the evening 5.00 PM to 7.00 PM only.

41. There shall be silent hours maintained from 10.00 PM to 6.00 AM in the hostels.
42. Strict maintenance of contact phone numbers (both landline and mobile) mail address and passport size photograph of parent (s) of every student boarder.
43. Contact numbers of the Warden, Caretaker and Ambulance driver shall be displayed in hostels is must.
44. First- Aid Box with emergency medicines should be made available in the warden room.
45. Regular visits of Wardens to Hostels and messes.
46. Sanitation in Hostels and messes should be strictly maintained.
47. Personal attention of Wardens and Chief Warden in timely and proper completion of repairs and renovation works.
48. Keeping Ambulance /Transport facility ever ready to take care of any medical emergency (24 x7) in the Hostels.
49. Verification of Cash books of Hostels by the Associate Dean, the Chief Warden, Principals of colleges shall be done time to time.
50. Mess Management Committee meetings shall be conducted regularly.
51. Timely contact of parents of the student boarders in case of any Emergency and also timely reporting of any odd behaviour / Indiscipline if noticed in the hostels.

**Prohibition of Ragging in the Educational Institutions-
Anti Ragging Measures**

The definition of the word “Ragging” was notified by the UGC in its regulations as “any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background”.

The directions from Andhra Pradesh State council of Higher Education (APSCHE), Ministry of Human Resources Development (MHRD), Department of Higher Education, Indian Council of Agricultural Research(ICAR) and Ministry of Youth Affairs & Sports, Government of India, Regional Directorate of NSS, Hyderabad illustrates the precautionary measures for prohibition of ragging in the colleges and also outside the colleges especially in hostels, various acts for giving wide publicity for curbing the ragging menace through print and Electronic Media, Pamphlets, Banners, Notices etc. on the Guidelines/Regulations.

Accordingly, it is the mandatory to the respective educational institutes under the University to conduct meetings with the senior students and people from the Academic Institutions, Judiciary, Police Department etc., on the Act Provisions and guidelines of the Hon’ble Supreme Court of India and the UGC on the issues of ragging.

The corrective measures recommended to curb the menace of the ragging in the Educational Institutions are :

A. Basic Measures

- a. Anti Ragging Cells.
- b. Anti Ragging Squad
- c. Help Desk
- d. Media Campaigning
- e. Formation of Anti Ragging Committees at college level
- f. Formation of Monitoring Committee of Anti Ragging at university level
- g. Giving prominent publicity inside and outside through boards posters at vital points
- h. Information Booklets for students / parents /staff covering ragging and indiscipline issues.
- i. Prospectus covering anti ragging and undertaking from the students / parents/ guardians
- j. Provision of CCTV Cameras at vital points i.e., at college campus and hostels.
- k. Action against the defaulting institutions
- l. Arranging alarm bells
- m. Anti Ragging Message
- n. Prohibition of Ragging posters may be exhibited in the College and hostel premises.
- o. Watch & Ward at Hostels should be properly monitoring.

B. Counseling and monitoring measures

- Conducting sudden and surprise inspection at hostels, students accommodation, canteens, rest cum recreational rooms, toilets, bus-stands and any other measure which would augur well in preventing/quelling ragging and any uncalled for behaviour/incident shall be undertaken.
- Convening the meeting with the inspector of police of respective circles and senior students with a view to motivate the provisions of the act on prohibition.

C. Creative Dissemination of the idea of ragging-free campus

- Provision of First aid Kits in the hostels.
- Provision of Anti Ragging Website
- Provision of Emergency Call Unit
- Anti Ragging Van
- Quick response teams
- Events like Anti-Ragging workshops, seminars and other creative avenues to spread the idea.
- Safety and security apps without affecting the privacy of individuals can be creatively deployed.
- Requesting the police officials to depute the police personal in the surrounding places of the institutions from the commencement of 1st year classes.
- Printing brochures so as to motivate the students and parents on anti ragging in the educational institutions.

D. Using other UGC initiated measures

- The UGC has developed 4 short films and a documentary film to counsel students on ill effects of ragging. These films are uploaded on UGC website All Universities/Institutions are requested to show these films regularly to the students during orientation and other programmes. In accordance with these regulations the action to be taken against those found guilty of ragging and /or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging is detailed:

***ACTION TO BE TAKEN BY THE HEAD OF THE INSTITUTION BY
THE ORDER OF HON'BLE SUPREME COURT:***

- Ø On receipt of any information concerning... any reported incident of ragging, the head of institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a first information report(FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;
- i. Violation of decency and morals through ragging;
 - ii. Injury to body, causing hurt or grievous hurt;
 - iii. Assault as well as sexual offences or unnatural offences;
 - iv. Extortion;
 - v. Physical or psychological humiliation;

Note : Kindly send an Investigation report by the Anti-Ragging committee duly signed by its members:

***UGC REGULATIONS ON CURBING THE MENACE OF RAGGING
IN HIGHER EDUCATIONAL INSTITUTIONS, 2009***

The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely;

- i. Suspension from attending classes and academic privileges.
- ii. Withholding/withdrawing scholarship/fellowship and other benefits.
- iii. Debarring from appearing in any test/examination or other evaluation process.
- iv. Withholding results.
- v. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, *etc.*
- vi. Suspension/expulsion from the hostel.
- vii. Cancellation of Admission.
- vii Rustication from the Institution for period ragging from one to four semesters.
- Viii Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of 3, ragging, are not identified, the institution shall resort to collective punishment.

- ✓ Ragging invokes **Suspension / Dismissal** from the College/**Imprisonment**

Teasing, Embarrassing & Humiliation	⇒	Imprisonment upto 6 months + fine upto Rs. 1,000/-
Assaulting or using criminal force or criminal intimidation	⇒	Imprisonment upto 1 year + fine upto Rs. 2,000/-
Wrongfully restraining or confining or causing hurt	⇒	Imprisonment up to 2 years + fine upto Rs. 5,000/-
Causing grievous hurt, kidnapping or rape or committing unnatural offence	⇒	Imprisonment upto 5 years + fine up to Rs. 10,000/-
Causing death or abetting suicide	⇒	Imprisonment upto 10 years + fine upto Rs. 50,000/-

The committee headed by Dr.R.K.Raghavan has made recommendations to curb the menace of ragging in the educational institutions - i.e. Anti Ragging Cells - Anti Ragging Committees - Anti Ragging Squad - Monitoring Committee of Anti Ragging - Help Desk - Emergency Call Unit - CCTV Cameras at vital points - Alarm bells - Media Campaigning - Prominent publicity inside and outside through Boards at vital points - Action against the defaulting institutions - Information Booklets for students/ parents/ staff covering ragging - in- discipline issues - Prospectus covering anti ragging and undertaking from the students/ parents /guardians - First aid kit - Anti Ragging Help line - Anti Ragging Message - Anti Ragging Website - Anti Ragging Van - Emergency Call Unit - Quick response teams - Sudden and surprise checks.

What is Ragging? Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.
